

**Camp Dixie Outdoor Ministry  
Release, Waiver, and Indemnity Agreement**

It is my intention by this agreement to exempt and relieve Camp Dixie Outdoor Ministry (hereafter referred to as "Camp Dixie"), and its officers, agents, or employees from liability for personal injury, property damage, or wrongful death of the Participant named above caused by any act of negligence of , and its officers, agents or employees.

For and in consideration of permitting the Participant named above to observe, or use any facility or equipment of Camp Dixie, or engage in and/or receive instruction in any activity or activity incidental thereto some of which may involve dangers and risk of bodily injury at Camp Dixie, Elberta, AL, Baldwin County, Alabama, beginning on the day of \_\_\_\_/\_\_\_\_/\_\_\_\_ (program start date) the undersigned parent and/or guardian of the Participant named above hereby voluntarily and absolutely releases, discharges, waives, and relinquishes any and all loss or damages or actions or causes of action for personal injury, property damage, or wrongful death occurring to the Participant named above as a result of the Participant named above observing or using facilities or equipment of Camp Dixie, or engaging in or receiving instructions in any activities some of which may involve dangers and risk of bodily injury or in activities incidental thereto wherever or however the same may occur, and for whatever period said activities or instructions may continue.

The undersigned parent or guardian of the Participant named above for him/herself, his/her heirs, executors, administrators, or assigns agrees that in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against Camp Dixie, or its officers, agents, servants, or employees, the undersigned parent or guardian will indemnify and hold harmless Camp Dixie, and its officers, agents, servants, or employees from any and all claims or causes of action by the Participant named above or by any other person or entity, by whomever or wherever made or presented, and under no circumstances will the undersigned parent or guardian of the Participant named above present any claim against Camp Dixie, and said persons for personal injuries, property damage, wrongful death, or otherwise, caused by any act of negligence by Camp Dixie and said persons.

The undersigned parent or guardian represent that he/she has read this Release, has requested and has been provided with, or has requested and declined advisement on the potential dangers/risks of engaging in the observation, activities, or instruction offered, assumes all risks associated with such dangers and risks, and is fully aware of and understands the terms and the legal consequences of the signing of this Release. The undersigned parent or legal guardian intends his or her signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**Authorization for Medical Treatment and Release of Information**

I hereby give permission to the medical personnel selected by the camp director to administer first aid, and to order x-rays, routine tests, and treatment. In the event of an emergency, I hereby give permission to the physician selected by the camp director to hospitalize, secure proper treatment for, and to order injection and/or anesthesia and/or surgery for the Participant named above. In the event I cannot be reached in an emergency, I hereby give permission to the physician selected by the camp director to secure and administer treatment, including hospitalization, for the Participant named above. I hereby agree to be responsible for payment of all costs or expenses of any health care provided or other person who acts in reliance upon this consent and authorization for treatment.

**Authorization for Off-Site Trips**

I hereby grant permission for the Participant named above to engage in off-site day and/or overnight trips and other enrichment activities that may be part of the specific camp program that the Participant named above is registered for. Furthermore, I hereby grant permission for Camp Dixie to transport the Participant named above to and from such off-site activities in camp designated vehicles or contracted bus services.

**Authorization for Photo Release**

I hereby grant permission to Camp Dixie use photographs and/or video images of the participant named above for use in official LuWiSoMo materials (print, internet, video, and other media) at the discretion of the Camp Dixie staff.
